In reference to captioned subject, we would like to update National Stock Exchange of India Limited (hereinafter referred as "Stock Exchange") about the return of draft scheme of Arrangement for demerger pursuant to Regulation 37 of the SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015.

The company had made the application for obtaining NOC under Regulation 37 of the SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015. However, the exchange returned the scheme due to non-compliance of SEBI Master Circular dated November 23, 2021 and Exchange's Standard Operating Procedure (SOP) dated December 20, 2022 on Scheme of Arrangement, which required that *the audited financials considered for valuations, other than Income Approach, should not be older than 3 months.*

However, the company will reconsider the Scheme of Arrangement on the basis of audited financial statements as on 31.03.2023 & apply for NOC in compliance with SEBI Master Circular dated November 23, 2021 and Exchange's Standard Operating Procedure (SOP) dated December 20, 2022.
